Joyce A. McCalla of Yellville will be forever known as a kind and compassionate woman, daughter, wife, mother, grandmother, sister and friend in the community.

Born April 15, 1953 in Little Rock to Ernest Jefferson and Dorothy Elnora (Deatherage) Bunt. Joyce passed away September 16, 2023 in Mountain Home. Joyce had lived in the area since 1969 and was a member of Yellville Missionary Baptist Church.

She was very easy to talk to because she was a great listener. Joyce helped hundreds of people in the community by working for the Department of Human Services. The ability to listen helped her assist people with their needs for 38 years in Marion County. In 2016, Joyce won the election to become the District 9 Justice of the Peace for the Marion County Quorum Court (MCQC). Joyce served the county with distinction trying to make the best decisions while serving as the chair of various committees. Joyce was always willing to talk (or brag) about her family. She loved her family very much, but when it came to the grandchildren, she glowed telling anyone listening about their accomplishments. Mrs. McCalla will be missed by everyone that met her and by others that knew what kind of person she was. Her legacy will live on in Marion County. Senator Scott Flippo

Arkansas State Senate
District 17

Scott Flippo is a native Arkansan, who was born and raised in Mountain Home.

Scott graduated from the University of Arkansas, where he received his Bachelor of Science in Business Administration.

Shortly after graduation he returned to Baxter County where he purchased his family's small business, Flippo's Carefree Living in 2003.

Scott Flippo's pride in North Central Arkansas is evident by the numerous hours he spends traveling the district, attending community events, and advocating for senior citizen and Veterans' efforts.

As State Senator, Scott has been recognized by Arkansas Right to Life, Arkansas Family Council, and Conduit for Action for his willingness to stand up for smart government reforms and conservative Arkansas values.

Flippo has also been recognized by the Arkansas chapter of the National Federation Independent Business and the Arkansas Trucking Association for his work to lower taxes and reduce the burden of government.

Flippo has also been endorsed by both Gun Owners of Arkansas and the National Rifle Association for his support of law-abiding citizens' Second Amendment rights.



Justice Barbara Webb

ARKANSAS SUPREME COURT

Barbara Womack Webb is currently serving as an Arkansas Supreme Court Justice. She has served as liaison to the Arkansas Court Reporter's Board and currently serves as the Court's liaison to the Access to Justice Commission.

Elected in 2020, she has over 20 years of experience on the bench and over 40 years of experience trying cases throughout Arkansas.

Justice Webb has served as a Special Supreme Court Justice, Circuit Judge, Chief Administrative Law Judge, and the CEO of a state agency.

She was the first elected Republican female Prosecuting Attorney in Arkansas and served as the first female Circuit Judge in Saline County. She has served on the Arkansas Ethics Commission, State Crime Lab Board, and the Coalition for Juvenile Justice.

The Justice has been appointed to positions by Governor Mike Huckabee, Governor Asa Hutchinson, Lt. Governor Win Rockefeller and in 2020, she was endorsed by Sarah Huckabee Sanders.

Her experiences uniquely qualify her to serve as the Chief Justice of the Arkansas Supreme Court. As Chief Administrative Law Judge at the Arkansas Workers' Compensation Commission, she oversaw the other administrative law judges and their caseloads; as CEO of a state agency she managed over one hundred employees and was responsible for the agency's budget and daily operations; as the elected Prosecuting Attorney she took over the office after her elected predecessor was investigated and later convicted of running the office as a criminal enterprise; she tried hundreds of jury trials and shut down over 500 meth labs; and as Circuit Judge she presided over a large docket of cases following the Judge's resignation for failing to pay Federal and State Income Taxes. In each case Justice Webb stepped forward to serve and improve the administration of justice.

She is principled, conservative, and experienced.

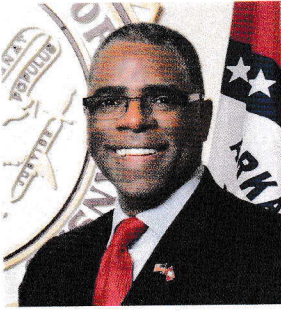

He has also served on the Veterans & Military Services Committee and the Broadband Task Force.

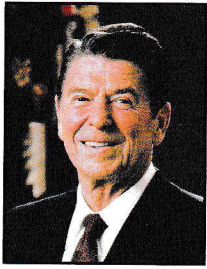
Prior to public service, Joseph was head of International Recruitment for Walmart Stores, Inc. and previously served as Assistant Director of Recruitment for the University of Chicago's Booth School of Business.

Active in his community as well, Joseph is a State Board member for The Call, a former Board member for the KIPP Delta Public Schools, a former representative to Sister Cities International, a former member of the Chancellor's Diversity Advisory Board at the University of Arkansas, a former board of director for the NWA Red Cross, and an active member of the Republican Party of Arkansas, serving two terms as Treasurer.

Joseph has published two children's books, *Saving Joey*, and *Adopting Joey* (Amazon and Kharis Publishing) about foster care, adoption, and his true life-story. He also wrote the foreword to two books, *American Vision 20/20*, and *The Hope of Things to Come*.

Abandoned in the streets at birth, he was placed in an orphanage and at age 10 was adopted by the Wood family. He grew up with his two brothers and sister in Chicago where his mother was an educator, and his father was a construction worker. He attended Iowa State University.
